BOOK OVERVIEW

The Treaty of Waitangi offers an up to date view of the complexities of New Zealand's founding document. As Orange states, it is about 'the relationship between the Crown and Māori, established by the Treaty of Waitangi in 1840.' *The Treaty of Waitangi* traces changes in this relationship through time and with reference to varying perspectives. The text takes a chronological approach, beginning with first contact between the British Crown and Māori, through the Treaty-making and colonial period, to the development of legislation relating to the Treaty and claims made by Māori in response to breaches. This updated second edition explores these key events and decisions relating to the Treaty up until 2010.

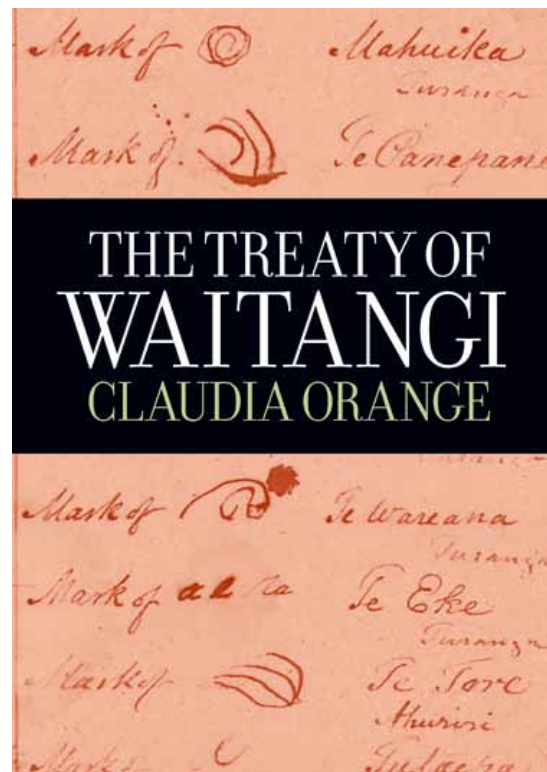

USING TREATY OF WAITANGI IN YOUR HISTORY PROGRAMME

This book gives teachers and students in-depth information on the development and the consequences of the Treaty of Waitangi. At Level 1 it is more ideal as a teacher resource. It could be used:

- by students in an inquiry into the significance of the Treaty of Waitangi in shaping New Zealand as a nation or the changing importance of the document in relation to Māori, Crown, the government and/or general populace (AS91229, AS91434, AS91435)
- to explore perspectives either directly in relation to the Treaty of Waitangi as an event or later important events related to Māori and the British Crown (or other) relations, such as the New Zealand wars, Parihaka, or the Treaty today (AS91004, AS91234)
- to write an essay which explores the causes and consequences of the Treaty of Waitangi or another related event caused by the Treaty (AS91233)
- to explore historiography by comparing Orange's explanation of key events surrounding the Treaty to other historians, such as James Cowan (nineteenth century), Lyndsay Head (neo-revisionist) (AS91437).

INDEPENDENT ENQUIRY IDEAS

The chronological structure of this text and extensive bibliography makes it accessible to most Level 2 and 3 students to use for independent enquiry.
